# PURPOSE

To assist Breeders with the associated costs of breeding a foal, from the time of insemination to when the mare has a live foal with the anticipation to stimulate breeding in NSW.

# **BROODMARE & FOAL ELIGIBILITY**

#### Part One – Positive Result Payment

- a) Broodmare must be domiciled in NSW from the time of first insemination for the season.
- b) If performing an Embryo Transfer (ET) the application form must be submitted to Harness Racing NSW prior to the procedure. A broodmare transported outside of NSW to perform an ET without an exemption from HRNSW prior to transport will be excluded.
- c) Broodmare confirmed to have a positive **42-day** pregnancy result as submitted to the Stud (proof of pregnancy should be available upon request from a veterinarian or a HRNSW licensed AI Technician).
- d) The Stallion must be nominated for the NSW Breeding Schemes.
- e) Mares that are not pregnancy tested are ineligible for the payments.
- f) Processing will not be undertaken after 30 June following the season of service.

# Part Two – Live Foal Payment

- a) Broodmares must conform to part one to be eligible for part two payment.
- b) Broodmare must foal in NSW.
- c) Resultant foal must be notified with Harness Racing NSW within 28 days of birth.
- d) Foal must be NSW Breeders Challenge or Trot NSW eligible.
- e) A full description of the foal, including markings, must be provided when the foal is notified.
  Additionally a minimum of four (4) photos clearly showing the offside, nearside, front and rear of the foal are to be provided.
- g) Foals will be microchipped in NSW by NSW representatives and the foal is required to be still on the mare at the time of microchipping unless approved in the first instance by HRNSW.

# Part Three – Live Foal Payment 100% NSW Bred (Blue)

- a) Broodmare and foal must conform to Part One and Part Two to be eligible.
- b) The foal must be NSW Breeders Challenge Blue or Trot NSW Blue Eligible.
- c) The stallion must be domiciled in NSW from the time it first covers a mare in the Australian breeding season until the time it last covers a mare in each breeding season.
- d) The advertised service fee of the stallion must be a minimum of \$2,000 (GST exclusive).
- e) A pacing stallion must cover a minimum fifteen (15) outside mares in a season not including free returns.
- f) A trotting stallion must cover a minimum five (5) outside mares in a season not including free returns.
- g) Processing will not be undertaken unless a foal meets the eligibility requirements of Part Three, and the requirements of Part Two are undertaken.

# SERVICES

Harness Racing NSW will solely rely on the services loaded by registered Australian and NZ Studs. It is the Managing Owners responsibility to ensure that the Stud has recorded the service result and destination correctly.

Service details can be checked on HarnessWeb (Foaling Details - HarnessWeb).

If a service is recorded incorrectly the Managing Owner / Stud must advise Harness Racing NSW in writing.

# PAYMENT

#### Part One Payment

a) \$250 payment to be paid to the Managing Owner for mares meeting the requirements to eligibility conditions - part one.

b) Payment to be made within 28 days of the Stud loading the official services with Harness Racing Australia.

#### Part Two Payment

a) \$1,000 payment to be paid to the Managing Owner once eligibility conditions – part two are met.

b) Payment will be made within 28 days of notification.

c) Should any foal not match the description or DNA profile that was provided at nomination, this foal will be deregistered until parentage is confirmed. All money that was paid in relation to this foal is to be returned to Harness Racing NSW. If any money is not returned to Harness Racing NSW within 28 days, the owner(s) will be placed on the Unpaid Forfeits List (UFL) until this is returned.

d) If any foal is deceased after foal notification, though prior to being microchipped and verified, the full payment shall be returned to Harness Racing NSW.

# Part Three Payment

- a) \$500 payment to be paid to Managing Owner once eligibility conditions parts two and three are met.
- b) Payment will be made within 28 days of notification.

c) Should any foal not match the description or DNA profile that was provided at nomination, all money that was paid in relation to this foal for 100% Blue Bred, is to be returned to Harness Racing NSW. If any money is not returned to Harness Racing NSW within 28 days, the owner(s) will be placed on the Unpaid Forfeits List (UFL) until this is returned.

d) If any foal is deceased after foal notification, though prior to being microchipped and verified, the full payment shall be returned to Harness Racing NSW.

All payments will be paid to the registered Managing Owner at the time of payment.

Loan of Mare forms will not be accepted, official Notification of Lease must be submitted prior to the mare being inseminated for any relevant payment to be paid to the appropriate person.

All payments will be made via EFT through Harness Racing NSW Stakes Run system.

It is the Managing Owners responsibility to ensure that the correct Bank Details are recorded with Harness Racing NSW.

# DISPUTES

If the Breeder does not receive payment then they need to advise HRNSW in writing. HRNSW is to be the sole decision maker in terms of disputes.

#### DEFINITIONS

**Outside Mare**: An outside mare is a broodmare not owned or leased by the stallion owner or the proprietor of the stud or their spouse/partner.

# **OTHER CONDITIONS**

Harness Racing NSW at its sole discretion will adjudicate on matters which are not in the spirit of the Breed NSW Scheme.

# EXAMPLES

A mare inseminated in NSW that returns a positive 42 day pregnancy to FOR A REASON (chilled NSW Sire) who then has a live foal born in NSW and registered and microchipped with HRNSW will be eligible to receive **\$1,750** in total.

- 42 day positive pregnancy test result \$250 payment
- Live foal, registered and microchipped with HRNSW \$1,000 payment
- 100% NSW Bred Foal (Blue) Additional \$500 payment
- Also eligible to claim the <u>\$500 Colonial Stallion Bonus</u>

A mare inseminated in NSW that returns a positive 42 day pregnancy to HUNTSVILLE (frozen NSW Sire) who then has a live foal born in NSW and registered and microchipped with HRNSW will be eligible to receive **\$1,750** in total.

- 42 day positive pregnancy test result \$250 payment
- Live foal, registered and microchipped with HRNSW \$1,000 payment
- 100% NSW Bred Foal (Blue) Additional \$500 payment

A mare inseminated in NSW that returns a positive 42 day pregnancy to QUAKER JET (frozen NSW Sire) who then has a live foal born in NSW and registered and microchipped with HRNSW will be eligible to receive **\$1,750** in total.

- 42 day positive pregnancy test result \$250 payment
- Live foal, registered and microchipped with HRNSW \$1,000 payment
- 100% NSW Bred Foal (Blue) Additional \$500 payment
- Also eligible to claim the <u>\$500 Trot NSW Incentive Certificate</u>

A mare inseminated in NSW that returns a positive 42 day pregnancy to ART MAJOR (chilled VIC Sire) who then has a live foal born in NSW and registered and microchipped with HRNSW will be eligible to receive **\$1,250** in total.

- 42 day positive pregnancy test result \$250 payment
- Live foal, registered and microchipped with HRNSW \$1,000 payment

A mare inseminated in NSW that returns a positive 42 day pregnancy to SWEET LOU (NZ Sire) who then has a live foal born in NSW and registered and microchipped with HRNSW will be eligible to receive **\$1,250** in total.

- 42 day positive pregnancy test result \$250 payment
- Live foal, registered and microchipped with HRNSW \$1,000 payment
